Access to Citepa's summaries

The members receive by e-mail in preview the Citepa's background files. These documents provide a description, an analysis and a contextualization of current political, legislative, regulatory and scientific events at national, European and international levels.

Members have access to Citepa's database which contains more than 1500 articles and files on political, legislative, scientific and technological news in the field of air pollution and climate change. This database is enriched with news items and articles that are published several times a week in the Air & Climate Watch section of the website.

Members receive an exclusive monthly summary "It's in the air" of the news published in the past month, classified by theme.

Technical and regulatory support

- Members can benefit from personalized technical and regulatory assistance, by e-mail or telephone, with an expert engineer on regulatory or technical subjects. In the case of simple requests, this is an immediate and punctual assistance. For more specific requests, a study estimate can be established.
- Members can receive an annual summary of regulatory and technical news on a chosen major theme, on request.
- Members can benefit from Citepa's training courses at a reduced rate.

Events

- Citepa proposes an original formula for sharing information on scientific subjects related to air quality and climate change: Citepa breakfasts. This formula allows real exchanges, in a friendly format, around a real breakfast. Some breakfasts are also accessible by videoconference. Members receive exclusive presentations and documents offering these webinars. Only members can come in person, at 48, rue de Paradis, to meet the speakers and other participants.
- Each year, Citepa organizes a study day on a topical theme, which is both a scientific symposium and a place for technical exchanges and political discussions. The study day is a privileged moment to meet the experts of the subject. It is offered at a reduced rate to members.
